Associates Fees: Fiscal Year 7/1/17 to 6/30/18

*Fees are assessed each fiscal year starting July 1<sup>st</sup> and ending June 30<sup>th</sup>.*

CPSC raises funds from foundations, business partners, the general public and other sources.

In 2016, the CPSC Board of Directors readopted a tiered Fee Schedule for local government Associates based on a per capita rate of \$0.02 from the 13/14 fiscal year. No jurisdiction is required to contribute over \$20,000 in any given year regardless of population size (although they are encouraged to do so if they can). Using this chart as a guide, each jurisdiction participating in CPSC is encouraged to self-assess the amount of fee due based on the population represented.

I	LESS THAN 10,000	\$ 250
II	10,000 – 25,000	\$500
III	25,000 – 50,000	\$1,000
IV	50,001 – 75,000	\$ 1,500
V	75,001 - 100,000	\$ 2,000
VI	100,001 - 150,000	\$ 3,000
VII	150,001 - 200,000	\$ 4,000
VIII	200,001 – 250,000	\$ 5,000
IX	250,001 – 300,000	\$ 6,000

Increases \$1,000 for every 50,000 in population with a cap of \$20,000
